The Company hereby informs the shareholders and investors with regard to the following:

IMPACT DEVELOPER & CONTRACTOR SA and BLUEROSE RO CORPORATION SRL concluded the Bilateral Sale-Purchase Undertaking authenticated under No. 464 of 11 April 2017 amended by Additional Act No. 1 authenticated under No. 712 of 29 May 2017, both documents authenticated by notary public Aron Mihai-Florin within Aron Florentina and Aron Mihai-Florin Professional Partnership of Notaries (the “Bilateral Sale-Purchase Undertaking”).

By Covenant No. 1094 of 17 July 2017 and Additional Act No. 1095 of 17 July 2017, both authenticated by notary public Aron Mihai-Florin within Aron Florentina and Aron Mihai-Florin Professional Partnership of Notaries, all rights and obligations arising from the Undertaking were transferred from IMPACT DEVELOPER & CONTRACTOR SA to BERGAMOT DEVELOPMENTS SRL (a company within which IMPACT DEVELOPER & CONTRACTOR SA holds 99% of the social capital).


Therefore, today, 17 July 2017, BERGAMOT DEVELOPMENTS SRL executed with BLUEROSE RO CORPORATION SRL the Sale Agreement authenticated under No. 1096 by notary public Aron Mihai-Florin within Aron Florentina and Aron Mihai-Florin Professional Partnership of Notaries, whereby BERGAMOT DEVELOPMENTS SRL acquired the land having a surface area of 22,982 sq m, located at Str. Clăbucet No. 68, Sector 1, Bucharest, in order to develop a residential complex of approximately 63,000 built sq m.

The acquisition price was EUR 10,571,720 plus VAT (reverse charge).

The price has been fully pay from the amounts borrowed by BERGAMOT DEVELOPMENTS S.R.L from IMPACT DEVELOPER & CONTRACTOR SA, based on the Loan agreement dated 14 July 2017 and disclosed to the market on the same day, *i.e.* 14 July 2017.
