Impact company informs the shareholders and investors on the fact that:

Case no. 60772/3/2011 on trial with Bucharest Court of Appeal has as parties the National Agency for Tax Administration – General Legal Division - as civil party, the individual Stegaru Ruxandra Maria – as defendant, SC Sqrw Development SRL – as civilly responsible party and SC Fondamento Forte SRL and SC Patagonia Invest SRL – as civilly responsible parties, through Impact Developer&Contractor SA - as successor in rights of the latter two companies, which it absorbed in 2005, 2007 respectively, pursuant to provisions of law 31/1990 on trading companies.

Bucharest Court pronounced in May, 2015 a decision by which it ordered the obligation of defendant Stegaru Ruxandra Maria, jointly with the civilly responsible parties Sqrw Development SRL and Impact Developer&Contractor SA, to pay the civil party the amount of RON 4,799,910 as de material damages, to which the accessory tax obligations afferent to the debt are added, calculated as from the due date of the obligation to pay until the date of debt full payment.

Impact states appeal.

In the procesual state of appeal, Bucharest Court of Appeal pronounced on the date of 24.03.2016, Decision 527/2016 respectively.

Bucharest Court of Appeal admitted the appeal of our company and regarding the civil part ordered, obliging the defendant Stegaru Ruxandra Maria, jointly with the civilly responsible parties Sqrw Development SRL and Impact Developer&Contractor SA, to pay to the civil party - ANAF, of the amount of RON **3,301,183**, as material damages, to which the accessory tax obligations afferent to the debt are added, calculated as from the due date of the obligation to pay until the date of debt full payment.

Principal and accessory tax obligations are integrally provisioned in the financial statements as of December 2015.

The decision is final.

We hereby mention that the liability of Impact company is not for its own deed, but for deeds of the individual Stegaru Ruxandra Maria.
